The American Recovery and Reinvestment Act (ARRA), signed into law by President Obama on February 19, 2009, is designed to jumpstart the U.S. economy, create or save millions of jobs and address national needs - while supporting unprecedented levels of transparency, oversight and accountability. Wisconsin's Community Action Agencies (CAAs), whose purpose is to help low-income households become economically self-sufficient and, in the process, help local communities grow and nurture their economic health, are fully committed to making ARRA work and, as the state's largest non-governmental recipient of stimulus funding, fully engaged in that effort.

Wisconsin CAAs received contracts and the federal ARRA funding from State agencies after passage of the State of Wisconsin Biennial Budget beginning July 1, 2009.

Wisconsin's Community Action Agencies have **created 261 jobs** with ARRA funding in the first six-months of reporting (through December 31, 2009) of which 202 jobs were directly paid with ARRA funds. In addition, CAAs utilized ARRA funds to retain another 221 jobs in their communities. Many of these jobs are employment specialists, housing counselors, community service advocates, weatherization auditors and installers - jobs that **provide important needed services to over 70,000 low-income people & victims of this economic recession.**

Community Services Block Grant

- Nearly 350,000 Wisconsin residents received help from their local Community Action Agency in 2009—an increase of nearly 40% and of nearly 100,000 people from 2008. The Community Services Block Grant provides resources to agencies to locally respond to problems of poverty and the economic recession.
- ARRA provides Wisconsin about \$12 million for the Community Services Block Grant. Total federal funding under ARRA for CSBG is allocated by formula to the States and, in turn, to Community Action Agencies. (For comparison purposes, Wisconsin received \$8 million in FFY 2010 for CSBG out of a regular FFY 2010 appropriation for the CSBG of \$700 million. President Obama's budget contains \$700 Million for CSBG for FFY 2011.)
- A total of 52,068 Wisconsin residents received help and assistance from the ARRA CSBG funds through their Community Action Agency during the 6 month period ending 12/31/2009. These funds are providing badly needed safety net assistance as well as economic opportunity to unemployed and low-income people and families throughout Wisconsin. Agencies have seen increased numbers of families at food pantries, homeless shelters, and free clinics. Agencies utilize the funds to address critical community needs as prioritized by the agency's board of directors including:
 - Providing safety net services helping families stay in their homes: Helping struggling homeowners avoid foreclosure; helping renters avoid eviction; preventing utility shut-offs; budgeting and financial literacy services; etc.
 - Expanding agency "job and business development" efforts to help low-income and other entrepreneurs create small businesses in "green" technologies or as trained weatherization sub-contractors.
 - Expanding the Community Action Skills Enhancement Program—helping low-wage workers get good jobs with benefits.

Weatherization:

- Community Action Agencies are the backbone of the federal Weatherization Assistance Program in Wisconsin for more than 30 years. 13 CAAs operate the program in their communities and produce more than half of the total housing units weatherized by the set of 20 program operators in the state.
- ARRA provides Wisconsin about \$145 million over two years for the Weatherization Assistance Program—from a total federal allocation of \$5 billion. In Wisconsin, the ARRA funds are administered by the State Division of Energy Services together with other federal funds and State Public Benefits funds. The State issued contracts to CAAs and to other weatherization program operators effective July 1, 2009 following the passage of the State Biennial Budget.

- **A total of 5006 housing units were weatherized** by the 20 program operators during the 6 months ending December 31, 2009; 3,043 housing units were weatherized by the 13 CAP agencies. Most of the completed total units (4,226 of the 5006) were weatherized using the State Public Benefits funds or funds from other than ARRA sources. ARRA funds could not be used until the US Department of Labor issued prevailing wage rates for every county (completed in early September 2009) and until subsequent new sub-contracts with local businesses and vendors could be rebid and awarded.
- Community Action Agencies have established 109 sub-contracts with local contractors, businesses, vendors, and partners performing weatherization work with ARRA funds in Wisconsin.

Community Action Agencies are **locally governed, non-profit corporations**, answerable to a Board of Directors comprised of representatives of local government, community and low-income persons. CAAs have been the epitome of **efficient, transparent, accountable** operation during their 40+ years of existence. The very nature of their Board structure keeps them accountable and CAAs also undergo yearly audits conducted by independent auditing firms. In addition, the State of Wisconsin Office of Recovery and Reinvestment as well as other State Departments are conducting field visits and site monitoring of agency operations and programs.
